TEAM SPORTS PROMOTE INTERACTION, BUILDING OF FRIENDSHIPS AND DEVELOPMENT OF UNIFIED SPORTS. IN 2017, BY MOVING SPORTS TO DIFFERENT SEASONS AND SETTING A GOAL TO MAKE BASKETBALL A SEPARATE SEASON AND EVENT IN MARCH 2018, SO UTAH WAS ABLE TO OFFER THREE SEASONS OF TEAM SPORTS IN BOTH TRADITIONAL AND UNIFIED SPORTS--SOFTBALL, SOCCER AND BASKETBALL, (2) PARTICIPATION IN A NEW SPORT. 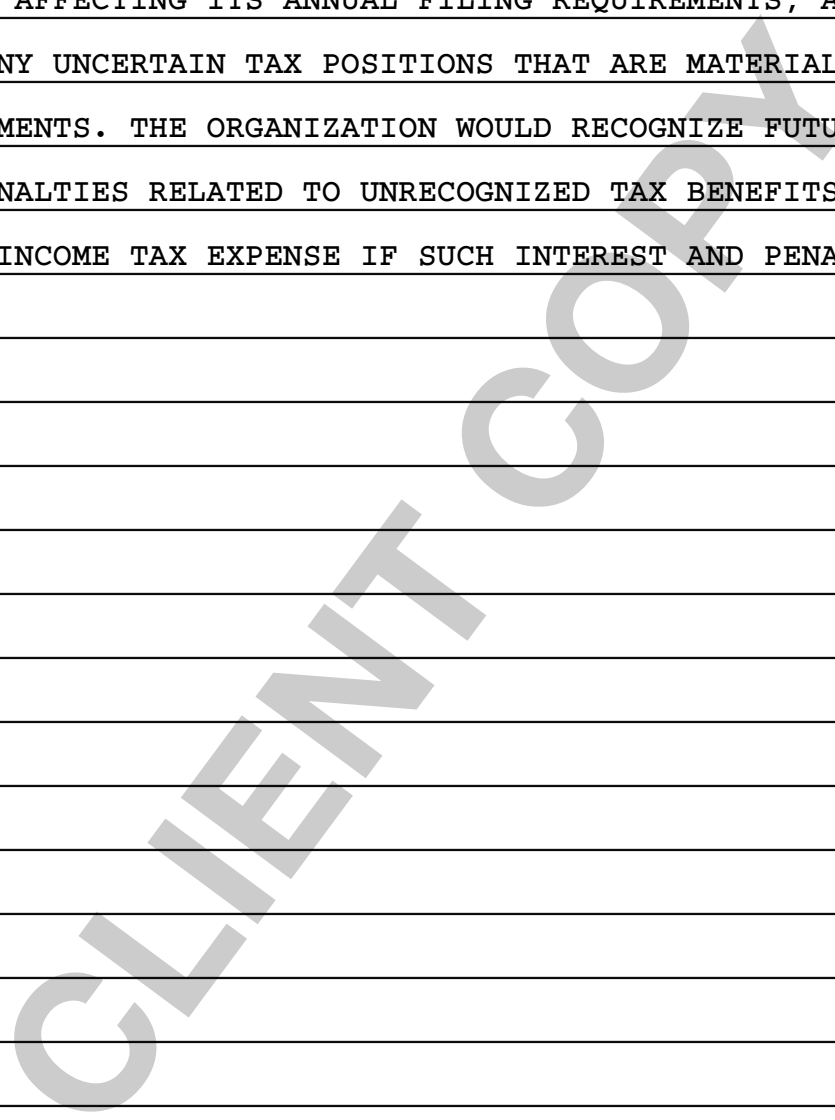
