SO UTAH HOSTED 26 AREA AND STATE LEVEL EVENTS SEEKING TO FULFILL THE MISSION OF YEAR-ROUND SPORTS TRAINING AND COMPETITION IN OLYMPIC-TYPE SPORTS. 2019 BEGAN WITH TRAINING IN SNOWSHOE, WHICH CULMINATED IN AN INVITATIONAL COMPETITION AT SOLDIER HOLLOW NORDIC CENTER. THE BASKETBALL SEASON INCLUDED AREA AND STATE COMPETITIONS. THE STATE TOURNAMENT IN MARCH WAS HELD AT THE UNIVERSITY OF UTAH. THE SUMMER SEASON QUICKLY FOLLOWED WITH SPRING TRAINING IN SWIMMING, ATHLETICS (TRACK AND FIELD), AND SOFTBALL. AREA GAMES WERE HELD FOR BOTH SWIMMING AND ATHLETICS.
